**1. Introduction**

This Privacy Policy sets out the types of information that Calls for Change ("CFC") collects about you, how CFC uses that information, and when and how you can limit our use of, correct, or review that information. CFC provides an email and text messaging service (the "Emails" and "Texts") for Users who register accounts through the Site (hereinafter the Emails, Texts and Site shall be collectively referred to as the "Service"). We're all about helping you move from enraged to engaged, so, except as we describe in this Privacy Policy, we're not interested in giving your data to third parties or selling your data.

By submitting your information as set forth in this Privacy Policy, you consent to CFC's use of that information as described in this Privacy Policy. Our privacy practices may change, and any changes will be reflected in an updated Privacy Policy that we will post on this page. If you continue to use our Service after we post a change to this Privacy Policy, you are signifying that you accept the updated terms, so please check the Privacy Policy periodically for updates. If you do not agree to the terms in this Privacy Policy, please do not access or use the Service.

**2. Children Under the Age of 18**

The Service is not intended for children under 18 years of age. No one under age 18 may provide any information through the Service. **3. What Information CFC Collects**

We collect several types of information from and about users of our Site, including:

- **Personal information** including first and last name, mailing address, phone number, and email address. We may also collect personal information about other people that you provide to us, such as their name, address, and email address. You can always decline to provide such information to us—it is your choice, and you are under no obligation to provide personal information to us. However, if you decide not to provide such information, then you may not be able to participate in, or request, certain services, information, or materials.
- **Non-personal information** including the internet protocol (IP) address of the computer you are using, the browser and operating system that you use, the date and time you access the Service, information about how you navigate the Service (frequency, time, where you click, etc.), and other information. The Service and any emails sent to you by the Service (or

otherwise by us) may utilize cookies, web beacons, embedded scripts, mobile device identifiers, or similar technologies that automatically collect such information about you.

#### **4. How CFC Collects this Information**

##### ***Generally***

CFC may collect information about you in several ways, including through cookies, automatically as you navigate through the Service, through your correspondence if you contact us, and directly from you when you provide it to us through the Service. You also may provide messages, text, illustrations, files, images, graphics, photos, comments, sounds, music, videos, information, content, and/or other materials to be published or displayed (hereinafter, “posted”) on public areas of the Site or Application, or transmitted to other users of the Service or third parties (collectively, “User Content”). Your User Content is posted on and transmitted to others at your own risk. Although you may set certain privacy settings for such information by logging into your account profile, please be aware that no security measures are perfect or impenetrable. - To personalize your experience (your information helps us determine who your members of Congress are and respond to your individual needs)
- To improve our Site and product (we continually strive to improve our services based on your feedback)

- To fulfill any other purpose for which you provide the information or as we describe when we collect the information
- to provide you with account notices including changes in the Service or related products or services
- to send promotional emails or texts about other information that we think you may find interesting
- for any other purpose with your consent.

## **6. Disclosure of Your Information**

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

We may disclose personal information that we collect or you provide as described in this Privacy Policy:

- to our subsidiaries and affiliates.
- to contractors, service providers, and other third parties we use to support our business or that provide services on our behalf.
- to a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by us about our Service users is among the assets transferred.
- to fulfill the purpose for which you provide it
- to comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- to enforce or apply our [terms of use](#) and other agreements.
- to protect the rights, property, or safety of us, our customers, or others.
- for any other purpose with your consent.

Except as described in this Privacy Policy, we will not sell, license, intentionally disclose your personal information to third parties.

## **7. Accessing and Correcting Your Information**
